## Town of West Boylston Finance/CIB Committee Meeting April 10, 2023

A meeting of Fincom and CIB was convened at Town Hall at 6:07 pm.

Attending Fincom and CIB members were Chris Berglund, Ray Bricault, Mary Foley, and Bill Fay. Paul Bohnson and Pete Murphy were absent.

VOTED: Approval of the Minutes of the April 3, 2023 meeting of the FINCOM and CIB, Moved by Ray Bricault, seconded by Paul Bohnson, All voted in favor, 5-0 for Fincom and 5-0 for CIB.

VOTED: To change the FINCOM reserve fund transfer originally moved and approved on 3/13/23 in the amount of \$21,500 such that the funds were to have been transferred in the amount of \$10,750 to the Ambulance Supplies Expense account and \$10,750 to Ambulance Purchase services account. The transfer was moved by Paul Bohnson and seconded by Bill Fay. Voted 5-0 by the FINCOM in favor of the change

VOTED: to Endorse the funding of the DPW capital request for a 1-ton F350 in the amount of \$110,000. Moved By Bill Faye and seconded by Ray Bricault. The vote was 2-2, with one abstention.

Bill Faye will be talking with the DPW to assess how the equipment would be maintained

The FINCOM and CIB then took up an initial vote of the draft warrant prepared by the Town Administrator as presented in her memo to the selectboard dated April 2, 2023.
