Parks Facilities/Maintenance Items

The board reviewed with Mike the written fall report that he had prepared.

- Fall clean-up 95% done
- Repairs to the irrigation Tim is working on, almost complete.
- Timer at the gazebo has been replaced.
- Test drillings for wells drillings have been done, waiting on report.

 Looking into requesting CPA funds for a well and development of a practice field.
- Tennis courts closed and lights are off for season. Steve noted the nets need to come down.
- Sidewalks and crosswalks paved 2 new sidewalks and crosswalks.
- Tree planting program Mike provided the 2013 RFQ and notice of award letter. Discussed
 possible locations for the trees, paying a landscape architect, or asking the landscape
 company who is providing the trees to give input.

- Practice Field (at pool site) assembling information on how much material will be needed, to have a price estimate that can presented to the CPC for funding request.
- Dugouts at sr. baseball field Steve noted that Athletic Association has funds set aside.
- Precast stairs can not be moved until the ground is frozen.
- Fencing project should be completed this week, if weather is good.
- Letter to BOS, DPW Director position Jim is working on.

- Ideas for Open Space handed out packets with information on updated the town's Open Space and Recreation Plan, to be reviewed and discussed at next meeting.
- Parks Commission Master Plan board needs to decide what is a priority and what needs to be done. Bob explained, that by law, it is the Parks Commission that has authority to maintain and develop facilities.
