- Pride Park – Town Administrator attended meeting to bring the board up to date on the Pride Park project. There were issues with the design and surveying and had to seek help from outside resources. Weston and Sampson has provided a proposal for design and engineering services (for the school side) and a draft of a contract has been sent to them. This will give a realistic cost of the project going forward and bid documents.






