Ray Bricault called the Finance Committee Meeting to order.

• Review and Approve Semi Annual Town Meeting Warrant for October 16, 2023

Ms. Warren-Dyment presented a redline draft warrant that was reviewed by Town Counsel. She jumped ahead to Article 15, Amendment to the General Bylaws, adding Article XLII, "Discharges to the Drainage System" which is related to the MS4 Permitting. She had conversations with Jaurice Swartz of Weston & Sampson and Town Moderator who chairs the Bylaw Committee and requested to remove this article at this time and add to the May Town Meeting. Mr. Crowley asked if this impacts the compliance, Ms. Warren-Dyment stated the Town is currently out of compliance and believes due to the Town working on becoming compliant there should not be any issues. Ms. Warren-Dyment reviewed all the changes suggested from Town Counsel, Mr. Crowley expressed his discontent with Town Counsel making changes to articles that they have approved in the past. Ms. Warren-Dyment provides explanation for each article.

OLD BUSINESS:

• Acceptance of Nuha Circle as Public Way (Refer Layout Plan to Planning Board for Review:

Ms. Warren-Dyment explained the Street Acceptance Procedure requires a street acceptance packet be submitted three months in advance and this request was not submitted as required. She spoke with Town Counsel and the Board can waive their own submission timeline. She explained Town Counsel has reviewed the Title Certification Plan and other documents

submitted by the developers Attorney and stated it is acceptable as to form. She state VHB, the Towns' Engineer has reviewed and provided comments and the key comment was in regards to a drainage easement. She explained there is a deviation in the location of the easement and the Planning Board has discussed at length. She read comments submitted from Mr. Vignaly of the Planning Board that the DPW Director and Building Commission recommended the Planning Board accept. Ms. Warren-Dyment explained the next step in the process is to intend that this be accepted as a public way and forward to the Planning Board for comments and recommendations. She stated they have a posted meeting tomorrow, September 28th and they can review and send a report back to the Select Board by September 29th and then the matter would be back before the Select Board on October 4th after considering the report of the Planning Board.

Motion Mr. Crowley moved to vote its intention to lay out Nuha Circle as a public way, all as shown on a plan entitled "Definitive Subdivision Nuha Circle Prescott Street West Boylston, Massachusetts", dated October 2, 2014, prepared by Bertin Engineering, and recorded with the Worcester South District Registry of Deeds in Plan Book 912, Plan 113, which plan is on file with the Town Clerk, and to forward this vote and the plan to the Planning Board for its comments and recommendations pursuant to G.L. c. 41, §§81G and 81I.; seconded by Mr. Morrissey.

 Execute Certificate of Release from Allowable Use Restrictions Under Paragraph 1 of the Declaration of Covenants and Restrictions (Westland Circle, Worcester Registry of Deeds- Book 53008, Page 286

Ms. Warren-Dyment gave the Board some background on the property and advised the Board that once a certificate of occupancy was issued for the homes on Westland Circle a Certificate of Release should have been issued at that time. She explained a recent title search found this had not been released. She requested the Board vote to partially release the lots from the allowable use restrictions.
