The Director:

Highlights include:

- Continuously developing and updating reopening plans, procedures and schedules.
- Attended two meetings with FinCom., as well as meetings with Trustees, Friends, Town departments and committees.
- Library staff hosted 36 programs for 304 patrons.
- Book bundles remained popular (15 bundles prepared for the month).
- Circulation was up, mostly in children's books.
- New England Mechanical repaired exhaust fan.
- Other building and equipment issues: RISE engineering (inspection of variable speed circulation pumps); elevator inspection; ADA expert sidewalks and accessibility.

OLD BUSINESS

- Installation of gutter screens in process (Barnard Roofing)
- Technology all staff computers running on Microsoft 365; all servers moved to the cloud; printer networking is next priority; transition from Guardian to CWMARS is going smoothly.
- Library services in person browsing activity is picking up; Saturday is the busiest day; patrons seem comfortable with the 30-minute browsing limit; no playtime yet in the children's room; library capacity limit is now at 60%.
- Reopening Committee same hours for browsing in May; staying closed at lunchtime; limited seating for reading the newspaper; expanding service hours (10-8 for browsing and computer usage) is planned for June; open non-fiction room in June; default pick up location is changed from curbside to the hold shelf at the desk.
- Director's Annual Review was discussed
- Long Range Plan community planning meetings were held; next step is to follow up with how
 the library can best support these goals; discussed the mission statement and decided to keep
 the current one for now.
- Green Communities Grant Projects RISE finished installation of variable speed boiler drives which should result in saving money on the electric bill.
- Front lawn accessibility sidewalks are crumbling; explore portable ramp versus granite curb removal.

NEW BUSINESS

- Signature policy should be on next month's meeting agenda.
- Closure of the library on Saturday, July 3 discussed.
- HVAC Energy Study Proposal discussed; goal is to submit this proposal in order to use green communities' funds to undertake the project.
- Town meeting flyer reviewed and approved it.
