COVID-19 Update

Ms. Salate provided general information about Covid case numbers. There was discussion around the reports showing outbreaks at the Worcester Correctional Center, which were not counted when issuing the mask mandate for West Boylston residents. Dr. Sullivan addressed questions about when the mask mandate will end, stating that the Board will continue to monitor the active cases and noting that as of yesterday, there were 277 active cases in Worcester County, with UMass having 60 patients with approximately 20 in the ICU. He noted that at this time the Delta variant is rampant in Worcester County, and vaccination rates in West Boylston show overall vaccination rate
