Public notice is hereby given, in conformity with the requirements of the General Bylaws of the Town of West Boylston, ARTICLE XXIII - PUBLIC HEARING AND NOTICE, that the Board of Selectmen will meet on Wednesday, March 14, 2018, at 6:48 p.m. for the purpose of considering amending ambulance rates. The meeting will be held in the Selectmen's Meeting Room, #210, 140 Worcester Street, West Boylston. Chief Welsh explained that the only rates he would like to increase are the BLS emergency base rate from \$1035.45 to \$1138.99, a 10% increase to bring us more in line with the average cost for this service and mileage from \$29.30 to \$32.23. He provided the Board with the Ambulance Rate Sheet which detailed the current cost and the cost being recommended. Ms. Bohnson joined the Board at 6:50. The Chief reports that no one contacted him with any questions.

There is no one present who wishes to speak on this item.
