- All Human remains must be placed in cement vaults, including cremains. Lowering devices, greens, and tents are NOT provided by the cemetery.
- Visitors are expected to act appropriately within cemetery property.

Decoration of Graves at Monuments


- Potted flowers and plants on lots are allowed during the Memorial Day period. In ground planted flowers should be in front of the monument at a distance of not more than one foot. Planting behind monuments is not allowed.
- In ground planting of flowers at flat markers is not allowed.
- All potted plants after Memorial Day should be moved back to the base of the monument. The number should be limited to two.
- Flowers or shrubs at or near the side of a monument may be planted only after agreement with the Superintendent. Trimming of shrubs is very time consuming and cannot be guaranteed. When shrubs have grown taller than the monument it should be removed. The Superintendent may remove shrubs after due notice to the Trustees.
- Winter Decorations to be removed by April 1st or earlier. Summer Decorations to be removed by October 1st or earlier.
- These rules are in place to help reduce maintenance costs and enhance the appearance of your cemetery. These rules super cede all previous rules and regulations. Prices of lots and services are subject to change. Cooperation and compliance is expected by all lot owners and visitors.
