### August 16, 2022 Meeting Minutes

Chairman Menard convened the meeting at 10:03 am

Trustees present: Mr. Menard, Mrs. Bohnson and Mrs. Mard

Also present: Mr. McKee

<u>Public Comment - There are no residents in attendance.</u>

Mr. Menard reviewed the financial documents presented at the July meeting.

Trash Receptacle Replacement — Mr. Mckee brought catalogs showing trash receptacles that could replace the 28 royal blue receptacles currently in the cemetery. The new receptacles that were purchased for the common cost about 1,200.00 each. Mrs. Mard suggested purchasing a few at a time and if it's possible to paint the remaining blue receptacles brown or green. When asked how often the receptacles are emptied, Mr. McKee replied weekly. He would also like to have a compost area. Mrs. Bohnson suggested buying additional concrete barriers to start a compost area. Mr. McKee would like the compost area to be at the dirt road that leads to the DPW. Mr. McKee will speak to Mr. Duffy about the new receptacles and come back to the trustees with prices. Mr. Duffy will be bringing the Storm Water code up to date. Upon motion of Mr. Menard and second by Mrs. Bohnson it was voted all in favor to purchase three receptacles like those purchased for the common not to exceed \$1,200.00 each. The funds will be taken from Cemetery Improvements and Maintenance account number 01-5420-5840.

<u>Paving</u> – Two quotes have been received from J. F. Grady Landscape Construction to pave behind the chapel and sections L-N. Chapel Road 7600 sqft. for \$34,000.00 and south 40 Road L-N 3000 sqft. for 13,500.00. Upon motion of Mrs. Bohnson and second by Mr. Menard it was voted all in favor to proceed with paving south 40 Road 3000 sqft for \$13,500.00. Work to be done by J.F. Gray Landscape Construction before winter of 2022. The funds will be taken from 01-491-5241-5840.

<u>Tree Cutting at the Proposed Paul X. Tivnan Road Cemetery.</u> Steven Gilette will do the tree cutting to the center of the proposed cemetery site very soon and thanks the Trustees for their patience.

<u>Line Trimmers</u> – Upon motion by Mr. Menard and second by Mrs. Bohnson voted all in favor to approve the purchase of two new line trimmers at a cost of \$400.00 each.

<u>Eagle Scout Project</u> – A letter from Jon Jameson dated July 23, 2022 is included with these minutes. The letter states Joh has completed his Eagle Project of adding Fire Department medallions thanks the Trustees for their help.

<u>Clothing Request</u> – Mr. McKee has requested permission to purchase sweatshirts and t-shirts for two employees. Motion by Mrs. Bohnson second by Mr. Menard voted all in favor to approve the purchase of sweatshirts and t-shirts for cemetery employees.

<u>Pinning and Mapping the Final Section of Mr. Vernon Cemetery</u> – Mr. McKee is hoping to begin the process of pinning and mapping th4 final section in Mt. Vernon Cemetery. The trustees suggested Mr. McKee look into an easier way to drive the stakes into the ground. Possibly renting some type of equipment.

The next meeting of the Trustees will be September 27, 2022 at 10:00 am at Town Hall.

Upon motion of Mrs. Mard and second of Mrs. Bohnson voted all in favor to adjourn at 10:55 am.
