The Mount Vernon Cemetery Board of Trustees are seeking quotes on removing damaged or compromised mortar and repointing same on our " treasured hidden gem"- The Holbrook Chapel.

The Holbrook Chapel construction was completed in 1891. It was gifted to the Town of West Boylston for use as a chapel for burials and tomb space for winter storage. Mount Vernon Cemetery along with The Holbrook Chapel were placed on The National Register of Historic Places in 2008.

The Holbrook Chapel is an 8-sided stone structure. The Holbrook Chapel is constructed with an all slate roof, including copper flashing and valleys. The exterior is round fieldstone with a stone block foundation. There are 8 original stained glass windows which complement the stone structure. The interior walls are decorative v-board and the roof framework is comprised of large handcrafted beams.

The mortar joints on the Holbrook Chapel have become weathered, weakened, and are beginning to fail. The Cemetery Board of Trustees are seeking quotes for work to be completed in full. The work will include removal of all poor mortar joints, including hairline voids. The contractor will be expected to enlarge the areas of compromise so that the appropriate mortar will bond. The Cemetery Board of Trustees expect that great care and attention will be used in matching existing mortar colors and restoring the existing raised mortar bead in all the exterior mortar joints. Enclosed are pictures of the building, showcasing **some** areas of concern. Below is a brief description of each side and some areas of concern.

Side A - Minor hairline cracks in mortar. A few pieces of mortar missing from foundation blocks

Side B – Minor hairline cracks in mortar. A few pieces of mortar missing from foundation blocks. $1'' \times 5''$ loss of mortar by top of window

Side C – This is the biggest area of concern. This side hosts the chimney which has water seeping into the fire box. Obvious compromise of mortar on the cricket side of the chimney. Voids of 1 inch or larger noted. The chimney will be reflashed with acceptable standard building practices. Should the current flashing not be salvageable, the awarded contractor will purchase replacement flashing. The accepted flashing will only be lead or copper. The majority of the wall has minor hairline cracks.

Side D - Minor hairline cracks in mortar. A few pieces of mortar missing from foundation blocks. Several large mortar pieces are missing around the window

Side E – Moderate voids in mortar on this side in some areas. Mortar missing around the windows. Large pieces of mortar are missing from foundation blocks

Side F - Minimal hairline cracks are noted. Small amount of mortar missing from under window

Side G - Minimal hairline crack are noted. Foundation blocks are missing pieces of mortar

Side H - Minimal hairline crack are noted. Foundation blocks are missing pieces of mortar

Firebox – The interior firebox will have all compromised mortar removed and repointed with color matched mortar and hardness approved by the Cemetery Board of Trustees. All of the interior red brick and its existing mortar must be cleaned from sediment and efflorescence.

The proposed work to be completed will benefit the town by preserving the historic Holbrook Chapel for many more years. The work will hit the CPA's goal #1 in "preserving, rehabilitating, and restoring" the structure of the building. The building is eligible for CPA funding, because it is listed on the National Register of Historic Places in 2008. A Building Permit will be required; however the fee will be waived. There will be no variance needed. The other approvals would be the Cemetery Trustees voting and approving the work to be completed.

The estimated time line for this project from start to completion may be up to 4 months, dependent upon weather.

The contractor will be expected on a daily basis to maintain a clean/safe job site. The site will be cleaned at the end of each day. Should a funeral procession enter the cemetery or a funeral service take place in the proximity of the work area, all work will cease until the event/service has ended. This will be communicated to the contractor on site by the cemetery staff.

The Cemetery Board of Trustees reserves the right to approve and/or reject the mortar color and hardness, both interior and exterior, prior to repointing.

The contract will be awarded in October 2019. If the contractor is not be able to start work until spring and/or weather permitting, more damage may incur during the winter months. The Cemetery Board of Trustees asks that the contractor will work with the town on assessing and pricing any additional work.

The awarded contractor will provide proof of insurance and workers compensation to the town upon being rewarded the contract.

The above is a casual observation, in no way does this limit or define the scope of the job to be completed. The Cemetery Board of Trustees and the Town of West Boylston will hold the contractor responsible for any incomplete or faulty work found on inspection by the Cemetery Board of Trustees at the completion of this work. Payment may be withheld until work is completed to the approval by the Cemetery Board of Trustees.

The Cemetery Board of Trustees request that the quote for this project be divided in to 2 parts. The first being the "C" side of the chapel, including the exterior and interior portion of the chimney. The second part shall be the entire exterior portion of the chapel excluding the "C" side, exterior chimney and interior chimney/firebox.
































MOUNT VERNON CEMETERY

MOUNT VERNON CEMETERY IS COMPRISED OF THREE DISTINCT ADJACENT AREAS COVERING 16.73 ACRES. THESE ARE THE BEAMAN CEMETERY, CIRCA 1757, MOVED HERE IN 1901 WHEN IT WAS DISPLACED BY THE WACHUSETT **RESERVOIR; THE OLD BURYING GROUND, CIRCA** 1792; AND MOUNT VERNON CEMETERY, 1852. THIS CEMETERY IS SIGNIFICANT FOR ITS ASSOCIATION WITH THE OVERALL SETTLEMENT OF WEST BOYLSTON, FROM THE EVOLUTION OF THE TOWN'S EARLY CENTER. TO ITS RETURN IN THE LATTER 19TH CENTURY. **IT IS ALSO SIGNIFICANT FOR ITS** COLONIAL/FEDERAL BURIAL GROUND AND MANY EXCELLENT REPRESENTATIONS OF **REGIONAL GRAVESTONE CARVINGS.** THE HOLBROOK CHAPEL, CIRCA 1891, IS A CHARMING VERNACULAR EXAMPLE OF VICTORIAN ECLECTIC ARCHITECTURE. MANY EARLY SETTLERS AND OTHER PEOPLE IMPORTANT IN WEST BOYLSTON'S HISTORY ARE BURIED HERE, INCLUDING EZRA BEAMAN, THE FOUNDING FATHER OF WEST BOYLSTON.
