- From Sept 2018 minutes: Butch Jackson explained his department is inventorying street and stop signs and will be prioritizing locations for sign replacement as needed. It was agreed that at larger intersections, each street should have a sign, to better guide the drivers. It was also discussed that stop signs do not need to be at all "T" intersections except those of high volume or high risk.

- Process for Sidewalk Projects on Rt. 12: Butch Jackson stated he recently spoke to someone at MassDOT who stated that the only way to get sidewalks installed or repaired on a state road was through a TIP project.

- □ Rte. 140 Corridor:

From Oct 2018 minutes: CMRPC Presentation: Rich Rydant and Sujatha Krishnan from the CMRCP presented the findings of the Rte. 140 Corridor Study. The presentation went for about an hour with many pages of data and maps. The most notable point of the presentation was that the Committee needs to hold a public forum to collect public input on a design of the intersection. Then the Town has to decide exactly what it wants to do and develop a preliminary design to about 10%. Rich also reiterated that the new Baseball Park has temporarily taken over all of the State's attention at this point. (Marc reached out to Rich and Sujatha for info)

- From Nov 2018 Agenda: Preparation for the Public Forum on the Rt. 12/RT. 140 and Rt. 12/Franklin intersection projects
  - Set date
  - Committee trial use of maps, etc. to brainstorm intersection improvement options
  - □ Traffic counts from CMRPC
