To the Constables of the Town of West Boylston.

#### **GREETINGS**:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the inhabitants of the Town of West Boylston qualified to vote in elections and Town affairs, to meet in the Auditorium of the Middle/High School in said Town (at 125 Crescent Street) on Monday, May 15, 2017 at 7:00 p.m. in the evening, then and there to act on the following articles.

# ARTICLE 1 - AUTHORIZATION TO HEAR THE REPORTS OF OFFICERS AND COMMITTEES OF THE TOWN

To see if the Town will vote to hear the reports of the officers and standing committees of the Town; or take any other action relative thereto.

# ARTICLE 2 - AUTHORIZATION TO BORROW IN ANTICIPATION OF REVENUE AND TO ENTER INTO A COMPENSATING BALANCE AGREEMENT WITH A BANK

To see if the Town will vote to authorize the Town Treasurer/Tax Collector, with the approval of the Board of Selectmen, to borrow money from time to time in anticipation of the revenue of the Fiscal Year 2018, the period from July 1, 2017 through June 30, 2018, in conformity with the provisions of the Massachusetts General Laws, Chapter 44, Section 4, and to issue a note or notes as may be given for a period of less than one year in accordance with Massachusetts General Laws, Chapter 44, Section 17, and to authorize the Treasurer/Tax Collector to enter into a compensating balance agreement or agreements for Fiscal Year 2018 pursuant to Massachusetts General Laws, Chapter 44, Section 53F, or take any other action relative thereto.

# <u>ARTICLE 3 – AUTHORIZATION TO EXPEND FUNDS IN ANTICIPATION OF</u> <u>REIMBURSEMENT OF STATE HIGHWAY ASSISTANCE AID</u>

To see if the Town will vote to accept any and all state highway assistance funds authorized by the state legislature and approved by the Massachusetts Highway Department under the so-called Chapter 90 Highway Assistance Program to be expended for the maintenance, repair and construction of Town roads in anticipation of reimbursement under the direction of the Board of Selectmen and the Town Administrator for work on roads located on the State Aid Primary System as approved by the Massachusetts Highway Department, and further to authorize the Town Treasurer/Tax Collector, with

the approval of the Board of Selectmen, to borrow money from time to time during Fiscal Year 2018, for the period from July 1, 2017 through June 30, 2018, in anticipation of reimbursement of said highway assistance in conformity with the provisions of Massachusetts General Laws, Chapter 44, Section 6A, or take any other action relative thereto.

# ARTICLE 4 – SENIOR CENTER PROJECT

To see if the Town will vote to appropriate a sum of money to cover the cost of the full engineering and design of a new Senior Center facility, through project bidding, owners project management costs, and a portion of construction costs, including all costs incidental or related thereto, and, to meet said appropriation, authorize the Treasurer, with approval of the Selectmen, to borrow the full sum of said appropriation under G.L. Chapter 44, Section 7 and/or any other enabling authority and to issue bonds or notes of the Town therefor; provided, however, that the appropriation authorized hereunder shall be contingent upon approval by the voters of a ballot question to exclude the amounts required to pay for the bonds or notes issued for such project from the provisions of Proposition 2  $\frac{1}{2}$ , so called; and further, that any premium received by the Town upon the sale of any bonds or notes approved by this vote, less any premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with G.L. c.44, §20, thereby reducing by a like amount the amount authorized to be borrowed to pay such costs; or take any other action relative thereto.

# ARTICLE 5 – AUTHORIZATION TO AMEND THE PERSONNEL BYLAW FOR THE FY17 WAGE SCHEDULE

To see if the Town will vote to amend Section 5, Part AA, Classification and Compensation Plan of the Personnel Bylaw by amending the Classification Plan table and the Compensation Plan table to reflect a reclassification of the Cemetery Superintendent position to a non-exempt position; or take any other action relative thereto.

# ARTICLE 6 - AUTHORIZATION TO AMEND THE PERSONNEL BYLAW AND TO AMEND THE CLASSIFICATION AND COMPENSATION PLAN SO AS TO PROVIDE EMPLOYEES A COST –OF-LIVING PAY INCREASE IN FY2018 (2%)

To see if the Town will vote to amend Section 5, Part AA, Classification and Compensation Plan of the Personnel Bylaw to amend the plan to reflect a cost of living adjustment to all wage rates by 2%: or take any other action relative thereto.

# **ARTICLE 7- AUTHORIZATION TO SET THE SALARY OF ELECTED OFFICIALS**

To see if the Town will vote to determine and fix what salaries elective officers of the Town shall receive for Fiscal Year 2018 in conformity with the provisions of Massachusetts General Laws, Chapter 41 Section 108:

# ARTICLE 8 – AUTHORIZATION TO TRANSFER UNEXPENDED FUNDS FROM FISCAL YEAR 2017 APPROPRIATIONS

To see if the Town will vote to transfer from available funds, or Fiscal Year 2017 appropriations, hitherto made, to Fiscal Year 2017 appropriation accounts; or take any other action relative thereto.

# ARTICLE 9 - AUTHORIZATION TO APPROPRIATE FROM THE FY17 BUDGET FOR FY18 POLICE RETIREMENT RELATED EXPENSES

To see if the Town will vote to transfer a sum of money from the Fiscal year 2017 Police Department budget to be used to fund employee retirement benefits and related costs in Fiscal Year 2018; or take any other action relative thereto.

# ARTICLE 10 – AUTHORIZATION TO PAY BILLS FROM A PREVIOUS FISCAL YEAR

To see if the Town will vote to appropriate a sum of money to pay bills from a previous fiscal year being held by the Town Accountant for which no encumbered funds are available, or take any other action relative thereto.

# ARTICLE 11 – AUTHORIZATION TO APPROPRIATE MONEY TO THE SEWER ENTERPRISE ACCOUNT FOR FISCAL YEAR 2018

To see if the town will vote to raise and appropriate or transfer from available funds the sum of One Million, Seven Hundred and Thirty Nine Thousand, Five Hundred and Sixty One Dollars and No Cents (\$1,739,561.00) to the West Boylston Sewer Enterprise Account to be expended by the Board of Selectmen, acting as the Board of Sewer Commissioners, for sewer development, administration, assessment, operation, and maintenance expenses in Fiscal Year 2018 as follows:

# ARTICLE 12 -- ESTABLISH A SPECIAL REVENUE FUND FOR WBPA -- TV

To see if the Town will vote to accept Massachusetts General Laws Chapter 44, Section 53F <sup>3</sup>/<sub>4</sub>, which establishes a special revenue fund known as the PEG Access and Cable Related Fund, into which shall be deposited cable franchise fees, license proceeds and other cable-related revenues for the appropriation to support PEG cable televisions access services, and oversight, monitoring compliance of the cable operator and renewal of the cable franchise agreement, and any and all cable-related expenses, the fund to begin operation for fiscal year FY18, which begins July 1, 2017; or take any other action relative thereto.

# **ARTICLE 13 - FISCAL YEAR 2018 OMNIBUS BUDGET APPROPRIATION ARTICLE**

To see if the Town will vote to raise and appropriate, or transfer from available funds, such sums of money as may be necessary to defray the expenses and charges of the Town of West Boylston in Fiscal Year 2018, the period of July 1, 2017 through June 30, 2018, including the costs of public education, debt and interest payments, and providing municipal services; or take any other action relative thereto.

(The proposed draft of the Fiscal Year 2018 Operating Budget can be found after the text of the Annual Town Meeting Warrant. The budget format contains the budget figures for Fiscal Year 2017, and the Town Administrator's recommendations for Fiscal Year 2018.)

# <u>ARTICLE 14 – VOTE TO APPROPRIATE FUNDS FOR CAPITAL IMPROVEMENT</u> <u>PURCHASES</u>

To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to purchase capital items, with each appropriation being treated as a separate item; or take any other action relative thereto.

# ARTICLE 15 - VOTE TO EXTEND THE SUNSET CLAUSE ON PREVIOUSLY REAUTHORIZED CAPITAL APPROPRIATIONS

To see if the Town will vote to extend the sunset clause on the following previously approved authorizations:

# ARTICLE 16 – APPROPRIATE FUNDS FOR LANDFILL MONITORING WELLS

To see if the Town will vote to raise and appropriate or transfer from available funds for the purpose of installing additional monitoring wells, at the Town's landfill as mandated by the Massachusetts Department of Environmental Protection, and to cover any and all related expenses; or take any other action relative thereto.

# <u>ARTICLE 17 – APPROPRIATION TO FUND AN ELDERLY COMMUNITY SERVICES</u> <u>PROGRAM</u>

To see if the Town will vote to raise and appropriate or transfer from available funds, the sum of Fifteen Thousand Dollars and No Cents (\$15,000.00) to fund an Elderly Community Services Program for the purpose of providing compensation for services rendered for the departments, boards, and committees of the municipality to resident property owners who have attained the age of sixty (60) years, to be used to reduce the real estate property taxes for the property in which the elderly owner resides. Said program shall be subject to the following conditions in addition to any and all eligibility requirements promulgated by the Board of Selectmen:

- 1. participation in the program shall be limited to elderly residents of the Town who own property and are willing and able to provide services to the Town;
- 2. program participants shall receive compensation at the rate of \$9.00 per hour for each hour of service rendered for a total not to exceed One Thousand Five Hundred Dollars and No Cents (\$1,500.00) in any calendar year;
- 3. the Treasurer/Tax Collector shall comply with the wage, tax, and payroll deduction requirements of the state Department of Revenue and the Federal Internal Revenue Service, prior to compensating program participants; and
- 4. program participants who meet the eligibility guidelines established by the Board of Selectmen shall be selected for participation on a first come, first served basis,

or take any other action relative thereto.

# **ARTICLE 18 – APPROPRIATE FUNDS FOR PARKS MAINTENANCE**

To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to purchase fertilizer and pesticides for use at the parks, or take any other action relative thereto.

# <u>ARTICLE 19 – AUTHORIZATION TO APPROPRIATE FUNDS TO THE STABILIZATION</u> <u>FUND</u>

To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to the Stabilization Fund, or take any other action relative thereto.

# ARTICLE 20– AUTHORIZATION TO APPROPRIATE FUNDS TO THE CAPITAL INVESTMENT FUND

To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to the Capital Investment Fund, or take any other action relative thereto.

# ARTICLE 21 – APPROPRIATE FUNDS TO THE UNEMPLOYMENT TRUST

To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to the Unemployment Trust, or take any other action relative thereto.

# ARTICLE 22 – TRANSFER OF CEMETERY FUNDS

To see if the Town will vote to transfer the sum of \$3,994.00 from the Sale of Lots Account for necessary cemetery improvements; or take any other action relative thereto.

# **ARTICLE 23 - REAUTHORIZATION OF REVOLVING FUNDS**

To see if the Town will vote to reauthorize revolving funds for certain town departments under Massachusetts General Laws, Chapter 44, Section 53E <sup>1</sup>/<sub>2</sub>, for the following purposes stated in the table below, for the fiscal year beginning July 1, 2017, said fees of the revolving accounts to be expended by the authorized entity without further appropriation, and, further, to establish a new revolving fund for the fiscal year beginning July 1, 2017, for the following stated purpose, as shown in **bold italicized font** in the table below, with a funding source that has been certified as new revenue not used in setting the FY17 tax rate; or take any other action relative thereto.

# ARTICLE 26 - AUTHORIZATION TO AMEND THE GENERAL BYLAWS BY ADDING A LOCAL WETLANDS PROTECTION BYLAW

To see if the town will vote to amend the General Bylaws of the town by adding Article XXXIX Wetlands Protection Bylaw to read as follows:

# LOCAL WETLANDS PROTECTION BYLAW

# 1. Purpose and Intent

The purpose of this bylaw is to protect the wetlands and related water resources in the Town of West Boylston by empowering the West Boylston Conservation Commission (the "Commission") to enforce MGL c 131, §40, the Massachusetts Wetlands Protection Act (the "Act").

To this end, it is the intent of this local wetlands bylaw to protect wetland resource areas and interests, but impose no additional standards and procedures other than those of the Act. It will only allow the Commission to issue fines under the Town of West Boylston General Bylaw Article XVI - Penalties, and General Bylaw Article XXV - Non-Criminal Disposition of Bylaw Violations subject to the limitations herein contained.

# 2. Presumptions

Violations of the Act and the regulations related thereto (310 CMR 10.00 et seq., referred to herein as the "Regulations") warrant swift action to provide protection of wetland resources and interests. Adverse impacts upon wetlands and other water resources, as a consequence of a violation include, without limitation: erosion, sedimentation, loss of groundwater recharge, degradation of water quality and loss of wildlife habitat.

# 3. Enforcement Authority

The Commission shall have authority to enforce the Act and Regulations within the town. Violations of the Act or the Regulations (each, a "Violation") shall be deemed violations of this bylaw. This enforcement power is limited to the issuance of fines as stipulated in Article XXV – Non-Criminal Disposition of Bylaw Violations. Notwithstanding any provision to the contrary in the Act, the Regulation or elsewhere in these bylaws, each day on which the Commission serves a separate notice of a Violation shall constitute a separate Violation susceptible of enforcement hereunder.

# 4. Severability

The invalidity of any section or provision of this bylaw shall not invalidate any other section or provision thereof, nor shall it invalidate any permit or determination issued hereunder.
