Re: October 17, 2022 Semi-Annual Town Meeting

The 2022 Fall Town Meeting is scheduled for Monday, October 17, 2022 at 7:00 p.m. in the West Boylston Middle/High School Auditorium. Below you will find the schedule for Town Meeting Warrant preparation and review as approved by the Selectboard.

## 1. <u>September 2, 2022</u> - <u>Deadline for Money Articles:</u>

Warrant article requests from municipal officials, departments, boards, commissions and committees seeking appropriations or transfers of funds should submit these articles to the Selectboard no later than September 2, 2022. *Remember, requests for annual operating budgets should be acted upon at the May Semi-Annual Town Meeting.* Included in the article request submission to the Selectmen, there should be a written justification for proposed financial warrant articles explaining the need for the appropriation and why the request was not included in the FY2023 Budget Request Document submitted by the appropriate municipal official, board, commission committee, or department.

#### 2. <u>September 2, 2022</u> - <u>Deadline for all Other Proposed Articles:</u>

The Selectboard will accept proposed warrant articles for the October 17, 2022 Semi-Annual Town Meeting until noontime on September 2, 2022.

### 3. <u>September 7, 2022</u> - <u>Town Meeting Warrant Articles to be Presented to the</u> <u>Board:</u>

The Selectboard will be presented with the list of articles for the October 17, 2022 Town Meeting Warrant as part of its regular Selectboard Meeting.

#### 4. <u>September 20, 2022</u> - Draft Town Meeting Warrant

The Office of the Town Administrator will forward a copy of the draft October 17, 2022 Town Meeting Warrant to the Finance Committee, Personnel Board, Bylaw Committee, Capital Investment Board, Town Moderator, Town Clerk, Finance Director, Town Counsel, and other municipal departments.

#### 5. <u>September 21, 2022</u> - Final Review of Warrant:

The Selectboard will hold a special meeting with the Finance Committee, other municipal officials and committees and the public to review the October 17, 2022 Semi-Annual Town Meeting Warrant on **Wednesday, September 21, 2022,** at 6:00 p.m. The Selectboard will officially close and sign the October 17, 2022 Semi-Annual Town Meeting Warrant on this date.

#### 6. <u>September 30, 2022</u> - <u>Posting of the Town Meeting Warrant:</u>

The October 17, 2022 Semi-Annual Town Meeting Warrant will be posted in conformity with the town's bylaws.

#### 7. <u>September 30, 2022</u> - <u>Public Distribution of Warrant:</u>

The Office of the Town Administrator will distribute copies of the October 17, 2022 Semi-Annual Town Meeting Warrant to the public.

#### 8. October 17, 2022 - Fall 2022 Semi-Annual Town Meeting:

The October 17, 2022 Semi-Annual Town Meeting will be held at 7:00 p.m. in the West Boylston Middle/High School Auditorium.
