**Article 4 – Authorization to Appropriate Funds for Community Preservation Projects as Recommended by the Community Preservation Committee –**

- \$25,000 from Affordable Housing Fund to fund Community Housing Needs
- \$18,000 from Undesignated Fund to create parking at “Blueberry Hill” Town-Owned Recreation Land
- \$30,000 from Historic Preservation Fund for the repointing of the Holbrook Chapel Roof
- \$70,000 from Historic Preservation Fund for rehabilitation and painting of the historical portion of the Library
- \$16,000 from Historic Preservation Fund for preservation and rebuilding of the chimney on the historical portion of the Library
