#### ARTICLE 1 – SENIOR CENTER PROJECT

To see if the Town will vote to appropriate a sum of money to construct a new senior center facility, and purchase any related equipment, as well as architect and owners project management costs, including all costs incidental or related thereto, and, to meet said appropriation, authorize the Treasurer, with approval of the Selectmen, to borrow the full sum of said appropriation under G.L. Chapter 44, Section 7 and/or any other enabling authority and to issue bonds or notes of the Town therefor; provided, however, that the appropriation authorized hereunder shall be contingent upon approval by the voters of a ballot question to exclude the amounts required to pay for the bonds or notes issued for such project from the provisions of Proposition 2 ½, so called; or take any other action relative thereto.

#### ARTICLE 2 - AMEND WAGE SCHEDULE IN PERSONNEL BYLAW

To see if the Town will vote to amend the West Boylston General Bylaw Article XXI, section 5.AA Classification and Compensation Plan, by replacing the existing Grade 7 compensation line for the Town Clerk in Section AA 2) Compensation Plan with the new language as follows in italicized text:

# Time and Place at which the Town Meeting was convened Quorum Requirement

#### Special Town Meeting – February 28, 2018

Article 1, Section 3 of the Town of West Boylston's General Bylaws states that "One Hundred (100) legal voters, including the presiding officer and the clerk, shall constitute a quorum, provided that a number less than a quorum may vote an adjournment; and that not more than Seventy-five (75) shall be required to maintain a quorum once the meeting has been called to order by the Moderator and that a quorum of Seventy-five (75) be required to reconvene any adjourned session of any such meeting."

Elaine S. Novia, Town Clerk, informed Moderator Jonathan Meindersma that 392 registered voters were in attendance and that the quorum requirement as set out in the General Bylaws has been met. At 7:11 pm the meeting was called to order in the auditorium of West Boylston Middle/High School. At this time, voters still in line to enter the meeting continued to be admitted.

#### Question 1 –

By hand count vote of 285 in favor and 130 opposed, it was voted by 2/3rds majority to appropriate \$4,600,000 to construct a new senior center facility, and purchase any related equipment, as well as architect and owners project management costs, including all costs incidental or related thereto, and, to meet said appropriation, authorize the Treasurer, with approval of the Selectmen, to borrow the full sum of said appropriation under G.L. Chapter 44, Section 7 and/or any other enabling authority and to issue bonds or notes of the Town therefor; provided, however, that the appropriation authorized hereunder shall be contingent upon approval by the voters of a ballot question to exclude the amounts required to pay for the bonds or notes issued for such project from the provisions of Proposition 2-1/2, so called.

Procedure for Hand-Count at Town Meeting

As residents arrive at Town Meeting, they are asked whether or not they are willing to serve as a counter/teller in the event of a hand-count.

Eight counters are needed for the Auditorium. If there is an overflow room, such as the cafeteria, an additional four are needed.

When it is time to take a hand-count, the counters assemble for instructions from the 'head teller' and town clerk. Each counter is assigned a section to count. The auditorium is divided into four sections: the right side, the left side, the front half of the middle section and the rear half of the middle section. Two counters count each section and bring their total to the head teller. If there is a discrepancy between the two counts of the same section, they are asked to count again. Often, the count is repeated even if the numbers match, just to be certain no mistakes are made.

The head teller adds up the totals, brings the total to the town accountant who checks the addition and then determines whether the article passes or fails.
