- Each application is given a sequential number
- Personal information is redacted so the Scholarship Committee remains unbiased

Discussion

Applications disqualified as they do not meet the requirements of Mass. General Law;

- Applications 2, 10, 15 and 01-15 checked off no financial hardship
- Applications 13 & 14 did not check off yes or no

Kim D. Hopewell reiterated that Massachusetts General Law Chapter 60 sections 3C (b) states that the Scholarship committee shall take into consideration each recipient's financial need, character, scholarship record, and involvement in community work as well as extracurricular school activities.

• Application 5 had no school, no course study and no cost

Beth Schaper stated that many of the students apply at different colleges and do not know where they will go or what the expense would be.

Joyce Kujala called the Guidance Office to see why transcripts weren't signed. The Guidance Counselor, Christine Lanotte sent Joyce a letter on March 17th confirming that all transcripts were official.
