- The Fire Chief conducted a successful fire and emergency procedures drill with library staff

- Job descriptions are under ongoing review with the Town; the Director has been given a list of 12 towns to compare compensation rates. New job descriptions and their respective pay ranges are tentatively scheduled to take effect July 1, 2020
- The library received a state aid check in the amount of \$7,470.14
- Plumbing repairs are being made to the downstairs restrooms

Meetings are held at 5:00 PM at the Beaman Memorial Public Library on the first Tuesday of the month except as noted above due to elections or scheduling conflicts.

The Green Community Project will fund the replacement of fluorescent bulbs with LED lighting at an estimated yearly savings of \$2000 and the purchase of a dehumidifier and two refrigerators.

The Town of West Boylston Board of Selectmen Policy on the Closing of Municipal Buildings for Extreme Hazardous Weather Conditions was reviewed. The library may be closed under the direction of the Trustees if they deem conditions unsafe for staff and patrons, even if Town offices elect to remain open.

Snow accumulation on December 2-3 caused hazardous conditions at the library as the sidewalks and on-street parking spaces were not cleared of snow in time for normal operating hours. Because there is no way to determine when the DPW will complete snow removal during any given storm, it was decided that the library may be closed at the discretion of the Trustees until it is safely accessible. Communication with patrons will be important during these changing conditions; a possible solution is to provide updates via FaceBook every two hours as to when the library will reopen.

Approximately 35 metal folding chairs have been returned to the library following storage during renovations. These chairs are no longer needed by the library and will be offered to other Town departments.
